RECOMMENDATION

It is recommended that the Board of Directors authorize staff to prepare documentation requesting proposals from Professional Consulting Firms with Aquatic Design expertise.

DISCUSSTION

The Aquatic Facility Advisory Committee(AFAC) did not meet in January, February, or March, 2015.

The district did receive two or three proposals prior to the formal request being recommended and request for proposal letters being sent to Consultant firms. The Board may want to include these proposals and have these firms indicate that is their wish to have their proposals considered. One of those proposals indicated a 15 week time schedule and this time schedule is used in preparing the following.

Interested firms shall submit their proposals to arrive at the CARD office no later than Friday, April 10, 2015.

A select committee will review the proposals and choose three to make a $\frac{1}{2}$ hour presentation before the Board of Directors at a special board meeting Thursday, April 23, 2015.

The select committee could be composed of:

Two Board Members Robert Hinderer Two AFAC Members(One Chico Swim Asso.) CUSD Representative If the Board of Directors were to select one of the firms at the April 23, 2015 meeting and the firm could start the project on or about May 4, 2015 the 15 week time schedule could end on August 10, 2015. If the Board of Directors agrees with the recommendations proposed by the consultants the Board of Directors will determine what the next plan of actions should take place.
